Guidelines for students participating in classes conducted in direct contact at the Faculty of Chemical Technology and Engineering ZUT in the winter semester of the academic year 2020/2021

- 1. To come to classes are allowed only students without disease symptoms indicating SARS-CoV-2 infection (cough, temperature, muscle pains, chills, losing of the smell and taste senses) who had no contact with patients diagnosed with COVID-19 or those ordered quarantine or isolation and who have submitted adequate declaration to the teacher (a template for the declaration is included as an attachment to the following guidelines).
- 2. In all ZUT facilities the rule of covering mouth and nose must be obeyed.
- 3. Students should avoid forming groups before, during and after classes. Space of 1,5 m should be kept between students waiting for the classes and their mouths and noses should be covered.
- 4. Before entering didactic rooms participants should clean their hands carefully with soap and water and disinfect them or put gloves on.
- 5. To laboratory classes requiring to use laboratory equipment and chemical reagents each student is obliged to come equipped with personal protection aids: disposable gloves, a face mask, protective gloves and a cotton laboratory uniform.
- 6. In IT rooms students are obliged to work in disposable gloves.
- 7. Items that are not relevant for the classes should not be brought to the rooms.
- 8. If possible, each student should use their own stationary materials/items necessary to undergo the classes. No items should be borrowed from other participants.
- 9. During the break students are allowed to leave or stay outside the building where the classes are conducted on condition that the social distance the space of 1,5 m between other people is kept.
- 10. In didactic rooms only a limited number of people is allowed at the same time according to the information at the door of the room.
- 11. Student before entering the classes may leave any personal belonging in the cloakroom, however the University takes no responsibility for any items that are left there.
- 12. If a person observes any worrying disease symptoms (cough, temperature, muscle pains, chills, losing of the smell and taste senses) he/she should not come to classes. It is recommended to contact a doctor by phone in order to get medical advice twenty-four-hour helpline regarding quarantine and health phone 222 500 115, optionally to contact a district sanitary and epidemiological station in Szczecin (phone: 91 487 0313, 693 454 556, 661 038 020 hours 7³⁰-20⁰⁰; or 668 332 486, 694 493 767 beyond the working hours), or a hospital infectious ward, or, in case of deteriorating health condition, call 999 or 112 and inform on the possibility of coronavirus infection.
- 13. In case of imposed quarantine order or hospitalization connected with COVID-19 pandemic, the student is obliged to inform immediately about it, via electronic mail or by phone, WTilCh Dean's Office (wtilch@zut.edu.pl, phone 91 449 49 64 or phone 91 449 41 05) as well as teachers conducting classes in order to excuse his/her absences.

- 5) I undertake to inform immediately the faculty Dean's Office (e-mail: wtiich@zut.edu.pl, phone: 91 449 49 64) and the teachers conducting stationary classes with my participation if, since the day of submission of this declaration and before the end of the following semester, any of the circumstances listed in points 1) 4) change;
- 6) I undertake to inform immediately the faculty Dean's Office (e-mail: wtiich@zut.edu.pl, tel. 91 449 49 64) and the teachers conducting stationary classes with my participation and relevant regional sanitary and epidemiological services if within 14 days since my participation in classes I observe symptoms of COVID-19 disease;
